

# I. KEY INDICATORS

- The Water transport industry in Romania was represented by 246 companies at the end of 2016, compared to 242 in the previous year and 258 in 2014.
- The industry's net profit amounted to RON 68,069,209 in 2016.
- The industry's total revenue was RON 1,013,341,430 in 2016, down by 23.79% compared to the previous year.
- The combined costs of the companies in the Water transport industry reached RON 931,264,376 in 2016, down by 25.63% year-on-year.
- The industry's total revenue makes up 0.11% to the country's Gross domestic product (GDP) in 2016, compared to 0.15% for 2015 and 0.14% in 2014.
- A total of 2,490 people were employed in the Water transport industry in 2016, compared to 2,494 in 2015 and 2,214 in 2014.
- Most of the companies in the industry are based in Constanta, followed by Bucharest and Tulcea.

# **II. INTRODUCTION**

In 2016 the companies in the Water transport industry numbered 246, distributed in 4 sectors.




In 2015 there were a total of 242 companies operating in the industry. In 2014 their number totalled 258.

# **III. REVENUES**


The total revenue in the industry was RON 1,013,341,430 in 2016, RON 1,329,705,893 in 2015 and 1,165,346,814 in 2014.



The companies in the Water transport market of Romania earned combined net sales revenues of RON 918,167,665 in 2016.

In annual terms, sales marked a decline of 23.58% compared to 2015. In comparison to 2014 they dropped by 15.32%. In 2015 sales dropped by 10.80% year-on-year.


The Water transport industry total revenue make up 0.11% to the country's GDP in 2016, compared to 0.15% for 2015 and 0.14% in 2014.



We expect, based on the trend in the last three years, the total revenue of the Water transport industry to change at a compound annual growth rate (CAGR) of -6.75% in 2017.

The highest growth, of 19.92%, was recorded by Inland passenger water transport, while Sea and coastal freight water

transport registered the sharpest decline, of 39.35%.

# **IV. EXPENSES**


The combined costs of the companies in the Water transport industry reached RON 931,264,376 in 2016.

In annual terms, total expenses fell by 25.63% compared to 2015 and decreased by 15.19% in comparison to 2014.

We expect, based on the trend in the last three years, the total costs of the Water transport industry to change at a compound annual growth rate (CAGR) of -7.91% in 2017.

Inland passenger water transport marked the highest annual increase in total expenses, of 28.72%, while total expenses went down the most, by 43.10%, for Sea and coastal freight water transport.

The biggest spenders in the industry, with costs of over 10% of industry's costs, numbered 8, including MSC ROMANIA SHIPPING SRL, MOORHOUSE LOGISTICS LTD SRL, COMPANIA DE NAVIGATIE FLUVIALA ROMANA NAVROM SA, ROMAR SHIPPING AGENCY SRL, ROMNAV SA. The medium spenders, or those in the 5% and 10% range count 7 and include TRADING LINE SRL, MAYA S.D. TRANS SRL, EUROPRIM SHIPPING SRL, BEO TRADE COM SRL, EB WATERWAYS SRL. Below 5% threshhold are 231 companies, including MARIN RIVERLINE SRL, COSENA SRL, TRANSUTIL SRL, BIBIK TRADE SRL, NAVEX SHIPS SRL.

Employment expenses in the Water transport industry went up by 10.25% on the year to RON 117,692,859 in 2016.

The highest growth in labour costs, of 39.49%, was registered by Sea and coastal passenger water transport.

The monthly costs per employee in the Water transport industry averaged RON 3,939 in 2016, RON 3,567 in 2015 and RON 3,246 in 2014.



The Water transport's return on assets (ROA) was 7.42%, while in 2015 it amounted to 5.23% and 5.07% in 2014.

About 40.00% of the 10 leading companies in terms of net profit per employee are located in Constanta, while 30.00% are Bucharest-based and 10.00% are headquartered in Cluj.

# SeeNews Industry Report

The average net sales revenue per employee in the Water transport industry amounted to RON 368,742 in 2016, down by 23.45% compared to 2015 and down by 24.71% compared to 2014.

The Water transport sector generated an average RON 406,964 in total revenue per employee. In 2015 and 2014 the figure was RON 533,162 and RON 526,354, respectively.

The average total revenue per company in the Water transport industry decreased to RON 4,119,274 in 2016 from RON 5,494,652 in 2015. The 2014 value was RON 4,516,848.

A company in the Water transport sector made on average a net sales revenue of RON 3,732,389 in 2016, compared to RON 4,964,501 in 2015 and RON 4,202,816 in 2014.

The Water transport industry made 0.08% of the overall sales country-wide, reducing its market share by 0.03 pp.


Debt-to-assets ratio of the companies in the industry is 0.39 in 2016. It was 0.47 in 2015 and 0.46 in 2014.

A total of 2,490 people were employed in the Water transport sector at the end of 2016, compared to 2,494 in 2015 and 2,214 in 2014.


